- Multidisciplinary cultural arts professionals actively engaged in the creative industry field such as domestic and international artists, architects, designers, craft artists, planners, critics, etc
 - * For foreigners, creators who can communicate in Korean or English
- Those who are born between January 1, 1983 and December 31, 2003
- Those who can communicate in English
- O Scale: A total of 24 participants

Activities and Application Details

O Activities:

- 2023 Global Young Creatives Residency will be conducted in the form of an Art Week, aiming to facilitate substantial connections and expand networks through the invitation of internationally renowned experts and the selection of promising participating artists.
- For one week, participants engage in programs such as lectures, talks, workshops, tours, and networking sessions centered around three main themes: ① Roots environmental and traditional origins of Jeju,
 ② Pillars sustainability of various art fields through art, and
 ③ Branches and Leaves international exchange and infinite expansion. They share experiences and inspiration with each other.
- As such, a performance review report based on active participation and insights exchanged during the one-week period is requested to be submitted.

O Residency period: September 14 (Thur.) 10:00 ~ September 20 (Wed.) 20:00 (7 days)

O Residency location: The whole area of the Jeju Special Self-Governing

Province, Republic of Korea

- O Supporting services
 - 1. Transportation
 - After the Residency, participants will be reimbursed for round-trip airfare costs from their country to Jeju. Participants are responsible for purchasing their own plane tickets. UNITAR Jeju International Training Center will not provide plane tickets for participants.
 - Participants are expected to book the lowest-priced economy-class airfare available. Business-class or first-class airfare will not be reimbursed. Participants are encouraged to book flights at least 20 days in advance to avoid premium airfare pricing.

3) Notes

- ① The additional costs incurred due to personal choices such as seat selection, extra baggage, special in-flight meals other than the purchase cost of the plane ticket are the responsibility of individual participant.
- ② Reimbursement is only possible upon submission of supporting documents that clearly state the participant's name.
 - a. All claims for reimbursement of airfare must be documented by a copy of the original receipt or online receipt (in US Dollar). Credit card statements are not acceptable.
 - b. Documents that participants must submit to UNITAR Jeju International Training Center are:
 - An e-ticket with the airfare stated in US Dollar
 - An original receipt with the amount paid stated in US Dollar
 - A copy of your passport
 - All boarding passes to Jeju from the point of your departure
 - c. Please note that the e-ticket, copy of the original receipt, and copy of the passport must be submitted by September 7 (Thur.) at 18:00 Korea Standard Time at the latest, which is one week before the start of the Residency.
 - d. Participants must keep copies of the original documents in the event that the paperwork is misplaced or lost.
- ③ Reimbursement will only be made to participants who attend and complete the full schedule of the workshop program including the field visit, and when all documents are received. Reimbursement will be made via wire transfer in US Dollars.
- ④ Reimbursement will be provided for round-trip flight tickets that arrive and depart within a maximum of 1-2 days before or after the Residency period.
- ⑤ Participants are responsible for the local transportation in his/her country and arranging his/her visa including a visa fee.
- ③ Participants are responsible for arranging their own transportation between Jeju International Airport and their accommodation.
- ⑦ Expenses such as living costs other than meals during the Residency period are the responsibility of the individual.

4) UNITAR Jeju International Training Center only provides a limited financial assistance for participants. The table below represents the maximum amount eligible for reimbursement for round-trip airfare based on the participant's region. If the final airfare paid by the participant is lower than the amount specified in the table, then UNITAR Jeju International Training Center will only reimburse the exact amount paid.

2. Accommodation

- UNITAR Jeju International Training Center will make a lump sum payment for all participants' accommodation as checking-in on September 13 (Wed.) and checking-out on September 21 (Thur.).
 - * However, additional expenses incurred from using the minibar and pay-per-view channels in the room are the responsibility of the individual.
- 2) All participants will have their own individual room.

3. Meals

1) UNITAR Jeju International Training Center will make a lump sum payment for all participants' meals at selected restaurants with pre-arranged menu.

2) Three meals a day and snacks will be provided to all participants.

4. Networking and promotion

- 2023 Global Young Creatives Residency will provide practical networking opportunities through collaboration with prestigious cultural and arts institutions both domestically and internationally. (For example, arranging exchange sessions and participation in events such as openings and previews with artists from Jeju Museum of Art's international exhibitions; conducting promotion and networking through collaborations with Arario Museum, D&DEPARTMENT, Kim Chang-yeol Art Museum, and others.)
- 2) 2023 Global Young Creatives Residency will have an introduction session on the first day where participants can share their activities and interests.
- 2023 Global Young Creatives Residency will provide a pre-program booklet, a post-event report, and promote participants' specific introductions through various SNS media.
- 4) 2023 Global Young Creatives Residency actively foster the formation and connection points of future practical projects.
- O Required activities during the Residency
 - Stay at the location provided by UNITAR Jeju International Training Center during the Residency period.
 - Active and enthusiastic participation according to the order and progress of the event.
 - Write a performance report on the activities and results during the Residency period and conduct activity sharing. (Performance sharing session will be held on the 7th day of the Residency).
 - * The detailed information regarding the duration of the residency and the method of activity sharing will be discussed separately.
 - Consent and cooperation for the use of participant profiles, related images, press releases, and online community engagement.

O Notes for Selected Participants

- Selected participants are expected to actively participate in the programs during the Residency period. In the event of serious violation, they will be responsible for reimbursing expenses such as airfare and accommodation.

Selected participants must follow the instructions of UNITAR Jeju Training Center and proceed with procedures such as visa issuance and airline ticket purchase after signing a contract to participate in the Residency.
 - * Cannot be submitted by regular post or in-person.
 - * The submitted documents will not be returned. After the application deadline, no submission will be allowed. Also, no modifications will be allowed after submission.

 - Individual applications are accepted, and submitted documents will not be returned.

 - If there are no qualified candidates based on eligibility criteria during the final selection process, the selection of final participants may not take place.
 - During the event period, cooperation is required for the archiving and monitoring conducted by the 2023 Global Youth Creative Residency.
 - If false personal information is provided or false documents are submitted in the application, all or part of the application decision may be revoked in accordance with applicable laws and regulations.
 - The final selected participants are required to fill out a pledge form regarding the prevention of sexual harassment and violence, as well as a pledge form regarding the Travel Reimbursement Policy for travel expenses from the Jeju International Training Center.
 - Any matters not specified in this Call for Participants will be determined by the UNITAR Jeju International Training Center.
