Jeju, 12 May 2017

REPORT

29 May 2017

SUMMARY

The 14th meeting of the Culture Committee of United Cities and Local Governments (UCLG) was held in Jeju (Jeju-do, Republic of Korea) on 12 May 2017, in the context of the 2nd UCLG Culture Summit, hosted by the Jeju Special Self-Governing Province.

The meeting included a presentation and discussion of the activities undertaken by the Committee in 2016 and early 2017, as well as those that were foreseen until 2018, by addressing five major areas: Intelligence; Cooperation and Learning; Institutional Relations; Communication; and Governance. The work programme for 2017, including the forthcoming launch of the third edition of the International Award "UCLG – Mexico City – Culture 21", was approved. The newly-established UCLG Policy Councils were also presented. Finally, participants discussed the results of the 2nd UCLG Culture Summit, sessions of which had finished earlier that day.

This document presents the minutes of the meeting, as well as its agenda and list of participants.

1. Background

The **UCLG Committee on Culture** is the global leader of "**Culture in Sustainable Cities**". Our narrative is based on human rights, good governance, people-centered development and the co-creation of the city.

The UCLG Committee on culture is a unique meeting point. There is no other structure at a global level that gathers together cities, organizations and networks that foster the relation between local cultural policies and sustainable development.

The Committee on culture of UCLG is co-chaired by Buenos Aires and the Mexico City and vice-chaired by Angers, Barcelona, Belo Horizonte, Bilbao, Bogotá, Jeju, Paris and Porto Alegre. These cities are the "Board" or governance team of the Committee. The Committee on culture has a Secretariat located at the premises of UCLG World Secretariat in Barcelona.

The mission of the Committee is "To promote culture as the fourth pillar of sustainable development through the international dissemination and the local implementation of Agenda 21 for culture."

The Agenda 21 for culture is the first worldwide document establishing an undertaking by cities and local governments for cultural development. Around 700 cities, local governments and organisations from all over the world were linked to the Agenda 21 for culture on 1st January 2017. United Cities and Local Governments – UCLG adopted Agenda 21 for culture as its reference document in October 2004 (Executive Bureau of Sao Paulo), constituted its Working Group on Culture in June 2005 (World Council of Beijing) which was succeeded by the Committee on culture in October 2007 (World Congress of Jeju) and ratified in November 2010 (World Congress of Mexico), upgrading the consideration of culture within the World organisation.

On the occasion of the first Culture Summit of UCLG, held in Bilbao in March 2015, the Committee approved "Culture 21 Actions: Commitments on the role of culture in sustainable cities". This document supplements the Agenda 21 for culture and aims to be an international guide that is applicable all over the world; a tool that promotes knowledge, facilitates the exchange of good practices, and strengthens a global network of effective and innovative cities and local governments on this issue.

This document summarises the 14th meeting of the Committee on Culture, which was held in Jeju, Jeju-do, Republic of Korea, on 12 May 2017, in the framework of the second Culture Summit of UCLG (Jeju, 10-13 May 2017).

2. Summary of the meeting

Official opening

Ms. María Victoria Alcaraz, Coordinator of Cultural Cooperation and Capacity-building at the Ministry of Culture of the City of Buenos Aires, Co-President of the Committee on Culture, officially opened the proceedings and presented the agenda of the meeting.

Presentation and discussion of the state of implementation of the Committee's work programme 2016/17

Mr. Jordi Pascual, Coordinator of the Committee on Culture, introduced the activity report corresponding to 2016 and the work programme for 2017. Both documents had been circulated previously by e-mail to the members of the Committee, and printed copies were also available at the meeting.

The presentation addressed the five areas of work which serve to structure the Committee's activities, as follows:

1. Intelligence

Activities in this area include the holding of the 2nd Culture Summit in Jeju and the organisation of the International Award "UCLG – Mexico City – Culture 21", the next edition of which will be launched in 2017 and the award given in 2018. The coordinator introduced:

- The process of preparation and realisation of the 2nd Culture Summit in Jeju (ACTIVITY 1 "Culture Summit of UCLG" in the work plan of 2017 of the Committee).
- The realisation of the second edition of the International Award "UCLG Mexico City Culture 21", and the beginning of its third edition (ACTIVITY 2. International Award UCLG Mexico City Culture 21 in the work plan of 2017 of the Committee)

Jordi Pascual also highlighted the ongoing work to discuss and strengthen UCLG's key narrative on 'Culture in Sustainable Cities', which had involved a specific, highly-enriching session (led by the UCLG Consultant on Networks and Sustainability, Mr Toni Blanco) earlier that day in Jeju (ACTIVITY 5 "Key narrative" in the work plan of 2017 of the Committee).

Also underway was the preparation of a document entitled "Culture in the Sustainable Development Goals: A Guide for Local Action", a draft of which had also been circulated by email to the members of the Committee, with a view to publishing it later in 2017. Providing specific guidelines and examples on the integration of cultural aspects in the local implementation of the UN 2030 Agenda on Sustainable Development, the document aims to stress that this integration is already happening and that cities in the Committee on Culture were actively engaged. Additional tools, such as a video, could also be produced. These activities are connected to ACTIVITY 3 "Good practices and knowledge" and ACTIVITY 4 "UN Agenda 2030 and New Urban Agenda" in the work plan of 2017 of the Committee.

The Committee approved to launch the third edition of the International Award "UCLG – Mexico City – Culture 21", which will take place in 2017-2018. The calendar would be as follows: October 2017: launch of the call; 28 February 2018: deadline of the Call; September 2018: Awards Ceremony in Mexico City, probably connected to a global seminar on "cultural rights in the city". All members of the Committee congratulated Mexico City for its leadership in the Award.

The Committee celebrated the success of the 2nd UCLG Culture Summit and especially the leadership of the Governor of Jeju and his teams. The Committee approved to organise a third UCLG Culture Summit in 2019. A specific call will be published on this issue later in 2017, so that there is enough time to prepare the contents and the logistics of the Summit.

The Committee approved the activities undertaken in the area of "Intelligence" for 2017.

2. Cooperation and Learning

Mr. Jordi Baltà, Advisor on Culture in Sustainable Cities at the Committee on Culture, introduced the Committee's learning programmes, including Culture 21 Lab, Pilot Cities and Leading Cities.

- Culture 21 Lab is a short workshop on "culture in sustainable cities". It enables cities to self-evaluate their work in this field. It provides key basic information on the place of culture in sustainable development, and it is a useful way to raise awareness of this field among local stakeholders.
- Pilot Cities is a learning programme based on the 9 commitments and 100 actions included in Culture 21 Actions. Lasting for approximately 30 months, it includes

- local awareness-raising, international peer-review, capacity-building, pilot local projects, public seminars and elaboration of good practices
- The Leading Cities programme gives support to cities that have experience in the implementation of culture and sustainability, through measures in the areas of Cooperation and Learning (technical assistance, capacity-building, good practices), Leadership and Advocacy (participation in international events and processes) and Communication (website, social media).

The three programmes had been designed following the adoption of Culture 21 Actions and currently involved over 40 cities.

Cities that were currently involved in each of the three learning programmes were present at the meeting. Examples are Makati (Culture 21 Lab), Cuenca and Lisbon (Pilot Cities) as well as Bilbao, Bogota, Buenos Aires and Vaudreuil-Dorion (Leading Cities).

Jordi Pascual illustrated the Committee's work with Leading Cities with the example of Barcelona, where a specific exploration on the cultural dimension of tourism and the impact of tourism on cultural life was being prepared.

The Committee celebrated the success of the three learning programmes, and endorsed the valuable work that is being done. ACTIVITY 6 in the work plan of 2017 is devoted to this topic, namely "Leading Cities and Pilot Cities".

Catherine Cullen commented that the learning programmes are mainly being used by cities in Europe, North America and Latin America, and asked on the possibilities to design other learning schemes more suited to the needs of cities in specific regions, including Africa and Asia-Pacific. Jordi Pascual mentioned (a) the presence of Makati (the first city in Asia-Pacific to have organised a Culture 21 Lab) and the attendance to the Summit of Konya (a pilot city in Turkey, that is, in the Middle-East and West Asia section of UCLG) as examples of real interest in these regions on the "Culture in Sustainable Cities", and (b) agreed the Secretariat of the Committee should engineer innovative learning schemes, more suited to the needs of cities in specific regions (ACTIVITY 7 in the work plan of 2017); he also mentioned that discussions are underway with UCLG Sections and other partners.

The Committee approved the activities undertaken in the area of "Cooperation and Learning" for 2017.

3. Institutional Relations

Jordi Pascual introduced the various activities in the work plan of the Committee for 2017 that belong to "Institutional Relations and Partnerships", namely: ACTIVITY 8. Participation in UCLG processes; ACTIVITY 9. Global advocacy on culture; ACTIVITY 10. Partnerships with intergovernmental organisations, and ACTIVITY 11. Networks of cities.

Jordi Pascual highlighted the place given to cultural aspects in the Bogotá Commitment and Action Plan adopted at the UCLG World Congress in October 2016, and in the Declaration of the World Assembly of Local and Regional Governments approved in Quito a few days later.

- The 5th World Congress of UCLG (Bogotá, 15 October 2016) adopted the Bogotá Commitment and Action Agenda – this includes one area of Action entitled "Promote Local Heritage, Creativity and Diversity through People-Centred Cultural Policies".
- The World Assembly of Local and Regional Governments (Quito, 16 October 2016) committed to "integrate culture as the fourth pillar of sustainable development and take action to foster heritage, creativity, diversity and peaceful co-existence."

He stressed that there was stronger recognition of the importance of culture in these documents adopted by local and regional governments than in those emerging from the negotiations of national governments, such as the Sustainable Development Goals, and suggested that there were arguments to be proud of UCLG's work in this area.

Maria Victoria Alcaraz celebrated this success, and mentioned the importance to move from words to action. She asked the Secretariat of the Committee to continue in the "internal advocacy" within UCLG to make these commitments a reality.

Jordi Pascual presented the existing partnerships that the Committee on Culture is giving special attention. He mentioned that the one with the UN Special Rapporteur on Cultural Rights was particularly worth noting. Dialogue is also underway with UNESCO and the European Commission. Furthermore, Jordi Pascual referred to the willingness to strengthen dialogue and collaboration with UCLG's regional sections.

The Committee approved the activities undertaken in the area of "Institutional Relations" for 2017.

4. Communication

Ms. Sarah Vieux, Communications at the Committee on Culture, introduced work in this area (which is ACTIVITY 12 in the work plan of the Committee for 2017). She referred to the newly-redesigned Committee website, as well as the separate website for the International Award "UCLG – Mexico City – Culture 21" and the plan to establish a separate website to present existing good practices in late 2017 or early 2018.

Other communication channels include the Committee's bi-monthly newsletter and work on social media, which witnessed a significant increase in followers (particularly on Twitter) in 2016.

Jordi Pascual invited all participants to share relevant news and developments for further dissemination via the Committee's own channels.

The Committee celebrated the quality of the Committee's work in the area of Communication and approved the activities foreseen for 2017.

5. Governance

Jordi Pascual presented the cities that currently make up the governance of the Committee on Culture and informed that the Secretariat of the Committee did not receive any communication related to either new cities wishing to join governance team of the Committee (also known as the "board" of the Committee) or cities wishing to withdraw from the governance team.

He went on to explain that the next meeting of the Committee would ideally be held in Mexico City in September 2018, alongside a seminar on cultural rights which is foreseen in the context of the awarding of the third edition of the International Award "UCLG – Mexico City – Culture 21". Since the governance team would need to be reviewed on that occasion, he invited cities interested in joining or leaving it to inform of that beforehand. These actions belong to the ACTIVITY 13 "Governance" in the work plan of the Committee for 2017.

Finally, the coordinator mentioned the existence of an ACTIVITY 14 on "Partnerships with donors" in the work plan of the Committee for 2017, which is meant to be used to explore new partnerships, including donors and sponsorship agreements.

The Committee noted the report of the coordinator and approved the activities foreseen for 2017 under the area of "Governance".

The Policy Councils of UCLG

Ms. Carole Morillon (Statutory Team, UCLG World Secretariat) introduced the UCLG Policy Councils. This new instrument results from earlier internal consultations, which indicated that there was a need to strengthen political leadership within UCLG and to foster the participation of members, beyond those that make up the UCLG Presidency.

To this end, the World Congress held in Bogotá agreed to set up Policy Councils, which were later designed and adopted at the meeting of the UCLG Executive Bureau in Madrid, April 2017. Drawing on the themes included in the Bogotá Commitment and Plan of Action, four Policy Councils have been established – among them, Policy Council 2 covers "Opportunities for All, Culture and City Diplomacy, Key for Development and Peace". Each Policy Council would be led by 15 political leaders, which were currently being nominated.

The Secretary-General of UCLG, Mr. Josep Roig, explained that the establishment of Policy Councils was part of the revision of existing mechanisms, which had also involved a reduction in the number of UCLG Committees – this should ultimately enable those that continue to exist to have more resources available. He highlighted that Policy Councils were oriented towards policymaking and had a cross-cutting aim – therefore, the Committee on Culture should related not only to Policy Council 2 but explore transversality with others as well.

Assessment of the 2nd UCLG Culture Summit

Participants were invited to discuss their views on the 2nd UCLG Culture Summit, the closing session of which had taken place earlier that day.

Mr. Julien Chiappone-Lucchesi (City and Eurométropole of Strasbourg) congratulated organisers for the successful event.

Likewise, Mr. Enrique Glockner (Expert, Committee on Culture, UCLG) thanked the team of the Committee on Culture for their assistance and continued support. He also highlighted how the Committee's work had become broader and more complex in recent years.

Other issues

Jordi Baltà informed of the Committee on Culture's involvement, alongside other partners (including Culture et Développement, which was also represented at the meeting), in a special event entitled "Investing in Creativity, the Future is Now" that would be held in Brussels on 7 June, in the context of the European Development Days.

End of the meeting

Before closing the meeting, Jordi Pascual thanked the cities that make up the governance of the Committee on Culture for their continued engagement. He particularly thanked the leadership of two people: Eduardo Vazquez, Councillor for culture of Mexico (who could not attend the UCLG Culture Summit), "for his personal and sound leadership in the relation culture - social inclusion – citizenship and for the leadership of Mexico City in all elements related to the International Award UCLG – Mexico City – Culture 21", and María Victoria Alcaraz "for her support of the Committee's activities over many years, since its foundation in 2005, and for her guidance on global networking and advocacy for culture in urban policies".

In turn, María Victoria Alcaraz thanked the coordinator and the secretariat of the Committee on Culture for their work. She went on to encourage cities to apply for the next edition of the International Award.

She closed by stressing two keywords – participation and commitment, which had inspired the launching of the work of the Committee on Culture almost 15 years earlier. She highlighted the positive evolution that had been visible in the Committee's work over the years.
