Since its creation in May 2004, as an inheritor of the century-old International Municipal Movement, more than 250,000 towns, cities, regions and metropolises, and more than 175 local and regional government associations have joined this global network.

## UCLG Committee on Culture: Advocating for culture in sustainable cities

The UCLG Committee on Culture is a unique global platform of more than 900 cities, organisations and networks to cooperate and promote the role of “Culture in Sustainable Cities”.

Its mission is “to promote culture as the fourth pillar of sustainable development through the international dissemination and the local implementation of Agenda 21 for Culture”, to foster and make more explicit the relation between local cultural policies and sustainable development. The network learns through exchanges, discussions and debates. This narrative is based on human rights, good governance, people-centred development and the co-creation of the city.

The UCLG Committee on Culture meets officially at least once a year, leads a biennial Culture Summit and a biennial International Award. Since 2004, it has released more than 50 public documents, including reports, briefings, articles and policy statements. Its activities also include global campaigns and advocacy.

### The UCLG Committee on Culture builds on 3 fundamental documents:

#### The Agenda 21 for Culture (2004)

is the first worldwide document that promotes policies and actions by cities and local governments for cultural development.

2



#### The Policy Document “Culture is the fourth Pillar of Sustainability” (2010)

engages local governments to explicitly include culture in a development model that “meets the needs of the present without compromising the ability of future generations to meet their own needs”.

3



#### The toolkit Culture 21: Actions (2015)

updates and supplements the Agenda 21 for Culture and transforms it into 9 concrete commitments and 100 actions which promote self-assessment and innovation on the role of culture in sustainable cities. It is a cultural rights-based toolkit on culture and local development.

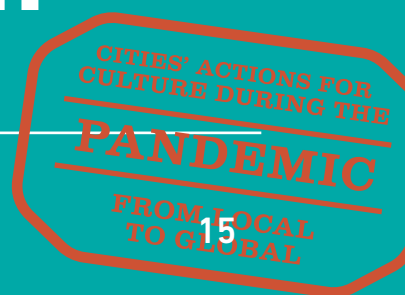

# Editorial

We constantly speak about culture: the sap of life, the drops of water that connect the roots and branches of a tree, the mortar that binds the communities together. Whatever we do in our lives, culture is present. Without culture there is no science, there is no economy, there is no politics, and there will be inequalities. Without culture there is no urban development, and there will be disasters. Without defining a new culture, we cannot define the future.

At the 4th UCLG Culture Summit in Izmir “Culture: Shaping the Future”, in September 2021, we jointly looked at life from that vantage point. The event gathered politicians, business decision-makers, intellectuals, leading experts, academics and activists from all over the world to exchange views; showcase the outstanding response of cultural communities to the pandemic of COVID-19; boost access and engagement in cultural life; identify new synergies and empower communities; expand rights and freedoms for all; build healthier and more resilient communities that leave no one and no place behind; and collectively endorse culture as an integrative and essential dimension of sustainable development. Izmir was also the place where the pioneer concept of “circular culture” was presented, with culture as the cement that teaches us how to live in harmony through four dimensions at local and global levels: Harmony with nature, addressing the climate crisis; Harmony with the past, understanding the cultures that lived before us; Harmony with each other, respecting the universal values of human rights; and Harmony with change, ensuring that cultural evolution is nourished by the creativity of young generations and the inspiration from Nature.

The conversations in Izmir also confirmed the rigorous work and commitments of the #Culture2030Goal campaign on the inclusion of culture in global development agendas, this being one of the main advocacy tasks of the UCLG Culture Committee together with other networks.

In the years 2020 and 2021, the Committee has also engaged in research on critical issues such as gender equality and climate change, and has taken a further step in capacity-building and cultural policy making at the local

level, with the creation of the Seven Keys programme, a locally grounded participatory workshop to integrate the cultural dimension in the localisation of the SDGs. The 4th edition of the International Award “UCLG – Mexico City – Culture 21” awarded Medellín and Segou in the “Local or Regional Governments” category, and Eusebio Leal and Vandana Shiva in the “Individuals” category. Moreover, and once again evidencing the leadership of local and regional governments in the field of culture and sustainable development, many of the proposals submitted to the Award were recognised as good practices and incorporated into the OBS, the database of good practices of the UCLG Culture Committee, which reached 287 practices by the end of 2021. Last but not least: the Rome Charter, a bold response to the COVID-19 crisis. The Rome Charter on “the right to participate fully and freely in cultural life” suggests its local implementation with these five capabilities: “Discover, Create, Share, Enjoy, and Protect”.

Local and regional governments have the legitimacy, and the power, to lead the global conversation on culture and development, and speak boldly about our future. I thank all the members of UCLG Culture Committee, and their partners, for the work they have achieved in the years 2020 and 2021. Now, let me conclude, I invite you to read this Culture 21 Review, and I also invite you all to work together, even more, in the coming years.

# Local Action

## Cities' actions for culture during the pandemic: from local to global

In 2020 and 2021, the COVID-19 crisis has extraordinarily affected the cultural life of cities, with implications for existing inequalities in access, participation and contribution to culture, access to public spaces, and the financial sustainability and the flow of cultural goods and services. This crisis has led to the mass closure of libraries, community centres, museums, galleries and cultural venues, and the cancellation of concerts, shows, festivals, exhibitions and many other cultural activities. Similarly, due to physical distancing and travel restrictions, cultural events and performances have been suspended and projects have been put on hold.

There has been a global call to cultural and creative sectors to join efforts, particularly in developing and strengthening digital resilience initiatives for cultural ecosystems, in order to guarantee citizens' access and participation in cultural life. Some emergency measures have been implemented to support workers in the cultural sector, who are very often in an already precarious situation (self-employed, freelancers), and to maintain the sustainability of cultural initiatives at all levels. Cities and local governments, with their workers, actors, institutions and networks, and in collaboration with national and international partners and civic society, have been making efforts to guarantee cultural rights and maintain activities to alleviate people's feeling of isolation and bring hope for a better future, and have contributed to promoting solidarity and fundraising to support the public health sector and workers.

In this section, we share an overview of the UCLG Committee on Culture cities' actions for culture during the COVID pandemic.

# 1. ACCESS TO CULTURE AND CULTURAL RIGHTS OF PEOPLE

During the COVID pandemic in 2020 and 2021, cities and local governments initiated and implemented the following actions and measures in order to address the impact of the crisis on cultural life, and to ensure access for citizens by promoting online access and/or adapting physical access to culture.

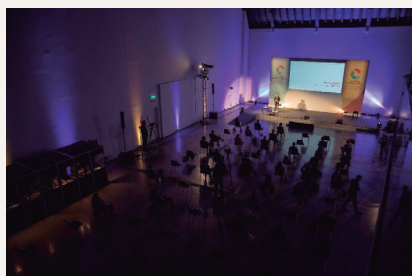
#### Vilnius:

The thematic session on "[Digital Technologies and the COVID-19 Pandemic](#)" organised in the framework of the [Live Learning Experience: Beyond the Immediate Response to the Outbreak](#) by [UCLG](#), [UN Habitat](#) and [Metropolis](#) on 15 April 2020, highlighted that while technology has proved key to the response of COVID-19, ensuring citizens' access to health services, culture, information and communication with competent authorities, local and regional governments are working to fight the digital divide as well and protecting citizens' digital rights, including principles of privacy, freedom of expression and democracy.

### LEADING CITIES

The City of **Rome** has demonstrated strong leadership through the [Rome Charter](#), launched in May 2020 in close collaboration with the UCLG Culture Committee. This document is based on a broad consultation process and is a milestone for cultural rights, as well as for the global conversation on culture and development. This was followed by different events, such as the Rome Hybrid Conference, to officially present the Charter; an [interview on the Charter](#) between Luca Bergamo and Emilia Saiz; and the celebration of the first anniversary of the document.

**Bilbao** City Council focused in 2020 on the theme of neighbourhoods and territory for culture with the aim of offering a universal set of basic programmes to guarantee the continuity of activities, and increase the sense of identity and uniqueness of each neighbourhood through cultural programmes and festivals. This work constituted a [good practice](#) of the Agenda 21 for Culture.

In 2020, the City of **Malmö** inaugurated its freedom of expression library, the Dawit Isaak Library, which subsequently became a good practice of the Agenda 21 for Culture. Also, the City Council of Malmö implemented several initiatives on culture and COVID-19, and initiated work to promote an anti-racist monument following a call published in the Swedish newspaper *Sydsvenskan* in 2019.

In 2020, **Barcelona** organised the round table "Culture is a Right. Urban policies and international context for cultural rights" with the aim of discussing frameworks of reflection and policies for the recognition and promotion of cultural rights in cities. The session had the participation of different cities of the UCLG Culture Committee, such as Rome, Mexico City and Lisbon.

## 2. SUPPORT TO THE CULTURAL SECTOR AND COMMUNITY SOLIDARITY

During this period, cities and local governments also initiated and implemented the following emergency measures in order to support the cultural sector, in particular cultural workers, to maintain the sustainability of cultural initiatives and activities, as well as to promote community solidarity through culture.

### **Barcelona:**

A package of measures to support culture in the city, such as special subsidies, advanced payments, special investment for the city's libraries, reorganisation of the calendar, etc.

### **Berlin:**

Emergency relief programme for freelancers and small businesses, online grant and bridging loan applications, online survey for city's artists, etc.

**Boston and the Massachusetts College of Art and Design:** Three-year regranting programme Radical Imagination for Racial Justice from Surdna Foundation to support artists of colour.

### **Brussels:**

Funding measures for cultural and creative sectors and non-profit organisations and intermittent cultural workers.

### **Bulawayo:**

Cultural and Creative Representatives released a Public Statement to Bulawayo City Council, the National Arts Council of Zimbabwe, the Ministry of Youth Sports, Arts and Recreation and other stakeholders.

### **Greater Amman Municipality:**

Colours of Soul and Hope, broadcasting interactive materials created by Jordanian artists to raise citizens' spirits.

### **Hong Kong:**

Support Scheme for Arts & Cultural Sector for small and medium-sized arts organisations and arts practitioners.

"Resistant Culture" package, financial and organisational support instruments, exchange of resources, knowledge and ideas, etc.

### **La Paz:**

Establishment of a Funding Scheme for Cultural Actors, Grants Call for Culture and the Arts, rescheduling dates and release of payment for the use of municipal venues, Forums for the Sustainability of Art Workers, generation of alternative spaces for culture, etc.

## LEADING CITIES

### Lisbon:

A set of extraordinary measures like the "Social Emergency Fund", the full exemption from the payment of rents, and full payment for the contracts already signed by cultural entities. Moreover, two other specific projects: Loja Lisboa Cultura provides training and information for the cultural sector, and Heróis da Cidade (Heroes of the City) recognises explicitly the labour of public workers.

### Linz:

Adjustment of funding guidelines and other measures, including the increase of studio rental subsidies.

### London:

Emergency fund, list of resources, advice, guidance and support schemes.

### Malmö:

Monitoring of the impact of the pandemic, measures such as not requiring repayment of grants for cultural activities that were cancelled or postponed, rent pause for 3 months, repayment plans, etc.

### Melbourne:

Grants to artists and creatives, digital presentation of works and performances, additional funds for local artists.

### Montevideo:

Books in kits with basic products distributed to the most vulnerable households.

### New York:

The manifesto of the People's Culture Plan shares an list of urgent demands for arts and culture to the Department of Cultural Affairs (DCLA).

### Paris:

Minimum pay level for artists and technicians, broadcasting and creation aids, endowment fund, etc.

### Rome:

Continuity of payment and funds disbursement to cultural agents, abolishing some taxes for cultural spaces, allocating new resources, and reorganising the data gathering system, etc.

### San Luis Potosí:

Strategies and measures to favour the exercise of cultural rights, like budgets for the cultural sector with the action plan "Resiliencies", the COVID-19 Commission of the IberCultura Viva Network of the Ibero-American General Secretariat (SEGIB), and the Local Charter for Cultural Rights.

### São Paulo:

Economic measures including Municipal Support for Cultural Projects, online cultural training budgets and artistic production budgets, hiring of cultural freelancers without income to generate online content, the relocation of signed contracts, Online Library project offering incentives actions to the culture and artistic sector, and Solidarity City project (Cidade Solidária), with the engagement of famous Brazilian artists who recorded a video encouraging communities.

### Sydney:

Cultural Sector Resilience Grant Programme for not-for-profits and sole traders, the Sector-Led Crisis Support Fund, the Creative Fellowships Fund for artists, Small Business Grants Program.

### Terrassa:

Package of aid for creation and production, maintenance of existing lines of subsidies, reprogramming activities, advice and continuous online support to cultural workers.

### Vienna:

Special grants for local freelance artists and scientists, maintaining of the funding system.

YopCreaLab workshops to empower and train people.

## LEADING CITIES

Within the framework of the Jeju Forum for Peace and Prosperity 2020, the city promoted the discussion based on the challenges posed by the pandemic in an online session on "The Role of Art and Culture amidst COVID-19". One year later, Jeju convened the 3rd Global Young Creative Residency (GYCR), in July and August 2021, formerly named "Global Youth Culture Forum" (GYCF).

### 3. COOPERATION IN TIMES OF PANDEMIC, MONITORING AND IMPACT DATA

During COVID pandemic in 2020 and 2021, cities and local governments initiated cooperation programmes and joint initiatives at local and international level in the context of the crisis. They also acted to monitor the crisis, improved their impact data and activated projects to collect oral, written, audio-visual and material memory of the pandemic.

#### \* PILOT CITIES

The Cities of **Concepción, Terrassa, Cuenca**, accompanied by Marta Llobet, from the UCLG Culture Committee and Jordi Baltà, from Trànsit Projectes, participated in the "Conversaciones en Confinamiento" (Confinement Talks) organised by Trànsit Projectes in July 2020: "Políticas culturales locales y desarrollo sostenible en el marco de la crisis post-COVID-19" (Local cultural policies and sustainable development in the framework of the post-COVID-19 crisis).

The city elaborated its work programme as a Pilot City in February 2020. The city also received a virtual peer-learning visit in October 2021 from the cities of Terrassa, Dublin and Barcelona, the regional section of UCLG of Asia Pacific (UCLG-ASPAC), the International Federation of Libraries and Associations (IFLA), the International Association of Educating Cities, the European Network of Cultural Centres and the Barcelona Provincial Council ('Diputació de Barcelona').

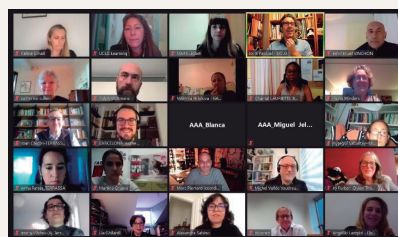
**Elefsina** adopted in July 2020 its work programme elaborated in the context of its participation to the Pilot City programme. The work programme has been drafted by Cultural Mediators Group, a group of citizens of Elefsina, after the results of the initial self-assessment workshop and the document resulting from it, known as 'Radar 1'. Advice has been provided by Clymene Christoforou. The work programme outlines briefly the actions which Elefsina plans to implement between mid-2020 and late 2021.

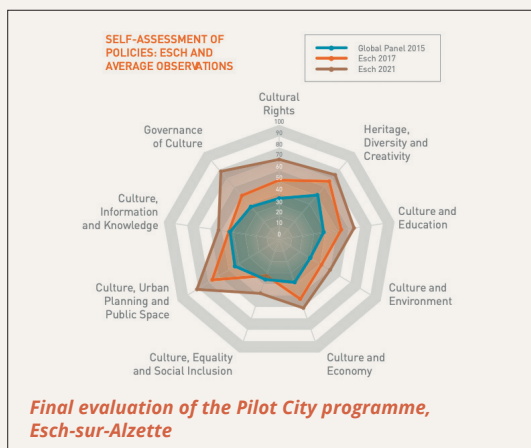

The City of La Paz realised the Final Evaluation of the Pilot City programme in September 2021 with local online activities of participative evaluation and an online seminary. The final report and the final article elaborated the City of La Paz gives an overview of its work within this programme.

## \* PILOT CITIES

**Leeds**, in the context of its participation to the Pilot City programme, elaborated its work programme in June 2021. The work programme was drafted by a group of local stakeholders, following the results of the initial self-assessment workshops held in October 2017 and February 2018, and the document resulting from it, known as 'Radar 1'. It also takes into account Leeds Culture Strategy which, in addition to the Agenda 21 for Culture's Pilot Cities Europe programme, includes a number of strategic projects.

**Terrassa** organised the virtual event Preventive Creativity, where nine UNESCO creative cities gave voice to artists, creators and intellectuals in online meetings to discuss solutions on cultural industry. This first meeting of artists and professionals from creative cities in Spain addressed the different realities of the cultural sector facing the current crisis, the artists' resilience in difficult adverse situations and the role of creativity in the reconstruction of cities for the future.

**Izmir** was designated as host city for the 4th UCLG Culture Summit, which in turn was considered one of the collective learning elements of the Leading City programme for Izmir. Within this programme, the municipality worked around the outcomes of the Summit, as well as the results drawn from the Seven Keys workshop (held in 2021) and the Pilot City programme (completed in 2019). The city organised workshops and webinar series, and concluded the Leading City programme by clearing the way to actively work on the projects raised during Seven Keys workshop.



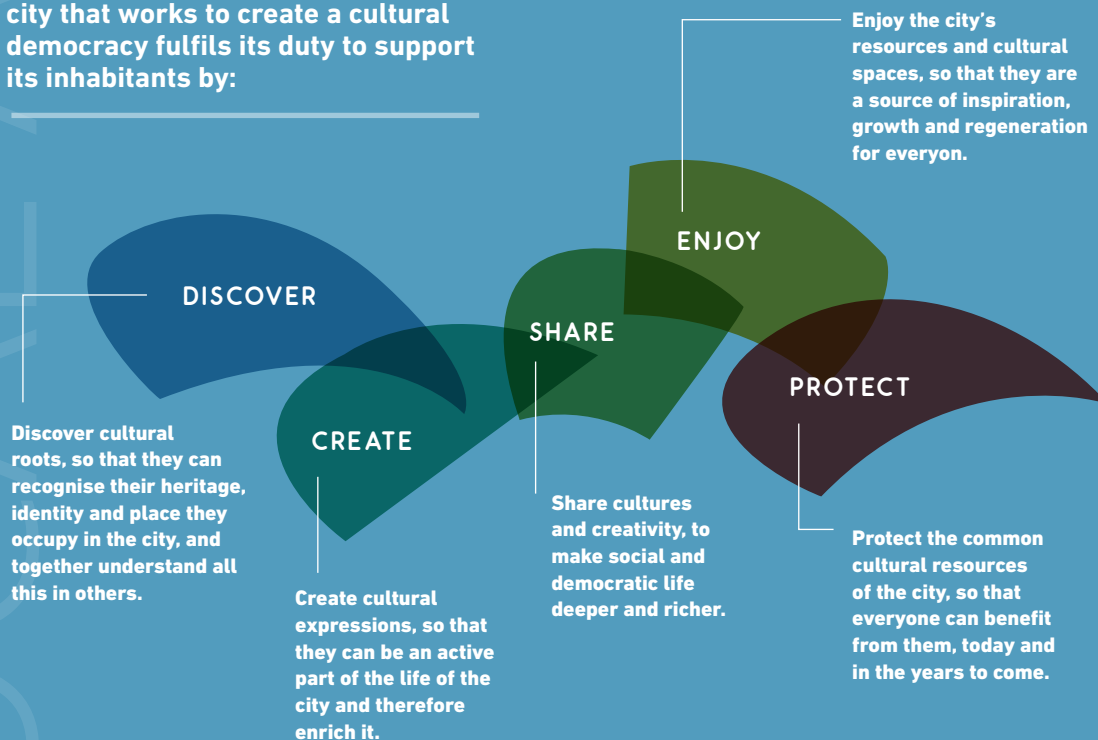

# THE ROME CHARTER

**The “Rome Charter” is the joint initiative of the local government of Rome and the UCLG Culture Committee on the Right to Participate in Cultural Life.**

The Charter calls on the Public authorities to meet their duties in respect of participation in culture, enshrined in the Universal Declaration of Human Rights and other international treaties and conventions, building bridges with the civil society’s formations and fostering coalitions both locally and in the global debate. Article 27: “Everyone has the right freely to participate in the cultural life of the community, to enjoy the arts and to share in scientific advancement and its benefits.”

**The Rome Charter affirms that a city that works to create a cultural democracy fulfils its duty to support its inhabitants by:**



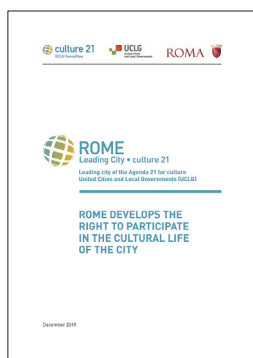

The Charter acknowledges that the people, are the city and therefore that cities are social formations, shaped by their citizens’ beliefs, values and creativity: by their culture. It provides local authorities, cultural operators, private sector actors and citizens with ideas, criteria and tools to support local actions aimed at developing common values respecting local cultures and conditions.



## BACKGROUND

The analysis feasibility of this initiative began in September 2019 and was informed by the fact that the Statement of Local and Regional Group in the Sustainable Development Goals (SDG) Summit that had taken place in New York in September 2019 (SDG Summit) included this paragraph:



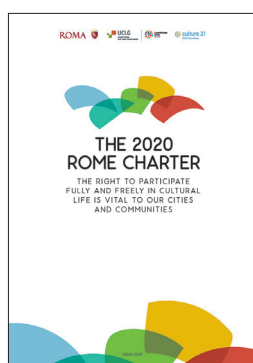
*We commit to promote culture as the fourth pillar of development and as a core component of local identity, and its role as a strand of global solidarity, and as a vector for peace and human rights. We further commit to foster locally relevant cultural policies and programmes on memory, heritage, creativity, diversity and knowledge which are key for local sustainable development.*

The Charter of Rome was published at a difficult and uncertain time. The COVID-19 crisis revealed the fragilities and injustices of societies, as well as the discrepancy between the people's demand for solutions and the limitations to which are subject the local governments tools and powers. Inequalities grew exponentially at every latitude and both the planet and the life it nurtures kept being considered merely a source of raw matter.

The crisis clearly showed how much current development models and their assumptions needed to be rethought. At the same time, to be inclusive and sustainable, the new models should be based on a real spirit of cultural democracy.

The Charter was a promise to the citizens of Rome, and to all the cities of the world.

The Rome Charter guarantees that local governments are entrusted with the necessary tools and powers so that equality in rights and dignity can be achieved.



## CONSULTATION PROCESS

The Charter is the result of a process lasting several months during the toughest time of the COVID-19 pandemic first wave, between April and October 2020, involving over 45 cities from every continent, 40 international networks and many experts. The consultation process that led to the Conference was one of the first "[Local 4 Action HUBs](#)" and it belongs to the "Local Experiences Transforming Global Policies". As a result, the final document integrates the Charter as well as the annexes "An Explanatory Note" and "Working with the Charter".

The Charter is offered as the basis of a debate of global relevance, under the auspices of UCLG and the City of Rome, with the support of its partners. It can become a great contribution of the international municipalist movement to efforts towards a new global development pact, where cities and local governments play a much greater role in the global governance, in a reinforced and improved multilateralism. The Charter is able to ensure that this exchange is genuinely global, including all voices.

## RELATED EVENTS

The Charter was first launched on 29 May 2020, on the occasion of the Executive Bureau of UCLG and it was approved at the World Council of UCLG on 13 November 2020.

The Charter was eventually presented and debated at the International Hybrid Conference organized in Rome and online from 1st to 3rd October 2020. The Conference was attended by more than 1 200 participants and had more than 110 speakers, representing all sections of UCLG, as well as key UCLG and global partners, during 3 days of debates, international interventions and dialogues dedicated to discuss the implications of the Charter in the development of sustainable cities and communities through participation in culture.

The [interview](#) between Luca Bergamo, former Vice-Mayor for Cultural Development of Rome and initiator of the Rome Charter, and Emilia Saiz, UCLG Secretary General, facilitated by Giorgio Barberio Corsetti at the Teatro di Roma, introduced the Charter as well. The interview allowed for a reflection on how to build and develop better societies for the future.

On 20 April 2021, UCLG, together with the City of Rome and Azienda Speciale Palaexpo organized a #CitiesAreListening session entitled "[Upgrading Culture in Sustainable Development: The Time is Now](#)". The session gathered mayors, councillors and local elected representatives from cities from across the planet and representatives from six global civil society cultural organisations. Together they discussed the need to reinforce actions and advocacy to defend and pledge for culture to be upgraded to its adequate value regarding development at the local level.

On 28 May 2021 an [informal and multi-voiced conversation](#) was organised on the occasion of the first Anniversary of the Charter with the aim of debating the place of cultural rights in short-term, mid-term and long-term development and post-crisis recovery strategies.

# THE SEVEN KEYS

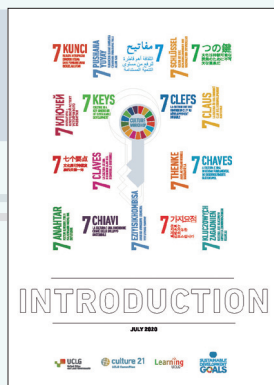


The Seven Keys is the newest programme of the UCLG Culture Committee, launched in 2020. This programme offers to cities, municipalities and regions a participatory workshop to integrate the cultural dimension in the localisation of the SDGs. It aims to enable participants to learn, debate and agree upon specific actions to explicitly connect culture and sustainable development in their city or town.

The workshop draws upon the United Nations' 2030 Agenda on Sustainable Development, which includes 17 Sustainable Development Goals (SDGs) and 169 targets to achieve them. The SDGs are being implemented between 2015 and 2030, with 2020-2030 being called 'The Implementation Decade'. The global organisation of United Cities and Local Governments (UCLG) believes that in order for the SDGs to be successfully achieved, they need to be localised – that is, adapted to local realities, and addressed with full ownership and engagement by local and regional governments and stakeholders. These should be provided with adequate resources, and their cultural diversity and cultural assets should be respected and recognised.

In this respect, UCLG also believes that the **SDGs cannot be achieved unless their cultural dimension is fully recognised and explored**. Although only a few of the SDGs and targets explicitly refer to cultural aspects, factors like heritage and memory, collective values, diversity, creativity, knowledge and participation in cultural life are essential in order to foster sustainable development and make lives meaningful.

# CULTURE WORKSHOP



The Seven Keys programme is based on the “acquis” of UCLG in this topic, and uses thoroughly the 2018 document “Culture in the Sustainable Development Goals: A Guide for Local Action” and the OBS of good practices.

Within this context, the Seven Keys programme offers to cities, municipalities and regions a local workshop that gathers participants from different areas of the local or regional government, as well as civil society and local cultural actors, to jointly identify and co-create Seven “Keys” or specific actions that they can commit to in order to localise the SDGs through cultural policy making in their city.

The specific feature of the programme is that the Seven Keys are always locally identified: each city / territory identifies their own seven keys. The workshop counts with up to 50 participants, coming from the different areas of the local government (Culture, Ecology, Planning, Communities, International Relations, Economy...) and others representing civil society (cultural sectors, grassroots organisations, activists, academics...) who can potentially contribute to identifying and enabling the Seven Keys in a trusty and creative environment.

The methodology of the workshop includes the following participative sessions:

**Local challenges and the SDGs:** An introduction to the SDGs and group discussion on relevant local challenges allow the participants to identify the main relevant SDGs in the context of their cities.

**Cultural mapping:** “What are the main aspects that make-up culture in your city or town?” Group discussion on tangible and intangible aspects, forms of participation, events, symbolic places, artistic and creative works, narratives, stories, etc. that can be related to culture allow the participants to identify the cultural assets of the city and to relate them to the SDGs.

**Spotting the gaps:** A facilitated collective discussion addresses the unexplored opportunities that exist to further connect the cultural aspects identified with the SDGs.

**Reaching the Seven Keys:** In four groups, participants analyse existing and potential measures that could contribute to the localisation and achievement of the SDGs by connecting culture and sustainable development challenges. Each group will later present its findings and proposals, and a debate of all participants will take place, aiming to reach a consensus and active commitment on the seven actions or ‘Keys’ that can be implemented locally.

**Visual documentation and closing:** Participants endorse the results of the workshop and a discussion on the next steps closes the day.

In 2020 and 2021, 4 cities have finished this programme. Namely: **Bulawayo** (Zimbabwe), **Lisbon** (Portugal), **Puerto de la Cruz** (Spain) and **Xi'an** (China).

## BULAWAYO:

The City of Bulawayo (Zimbabwe) and its civil society partner Nhimbe Trust/Bulawayo Cultural Affairs Office were the hosts of the first Seven Keys workshop on 10 December 2020. Bulawayo is a city of between 650 000 to 1,5m people, the 2nd largest municipality in Zimbabwe. The Bulawayo City Council has committed to localising the SDGs and is actively working with departments towards this end. It reports annually on 11 of the goals. It has also developed policies for gender equity, urban agriculture, public transport and a citizen's charter to meet the challenges it faces through policy interventions. Using the Seven Keys Workshop format, 9 representatives from diverse Bulawayo City Council departments, and 9 civil society representatives worked collaboratively to understand the challenges of Bulawayo. They looked at how these challenges were reflected in the SDGs, identified the city's cultural assets, spotted gaps and developed a set of unique keys relevant to their context to localise the SDGs using culture. Zayd Minty, expert of UCLG Committee on Culture, facilitated the workshop. The 18 participants agreed on the crucial importance of culture in the localisation and achievement of the Sustainable Development Goals. They developed 8 keys for the city of Bulawayo, since after identifying 7 keys they agreed to devote another one to gender issues only. The 8 keys relate to themes of economic development, education, environment and youth, and are strongly linked to tangible and intangible heritage.

## LISBON:

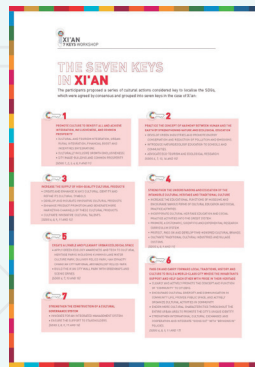
The city of Lisbon (Portugal) organised the Seven Keys workshop on 28 of June and 5 of July 2021. Lisbon, is the capital and the centre of the major urban agglomeration in Portugal. The actual policies of the city of Lisbon in the cultural area are rooted in the principles of the Agenda 21 for culture, for which it was nominated as "Leading City" in its implementation, by the UCLG Committee on Culture. The organisation of the Seven Keys workshop follows up on this process, with the objective to contribute to a larger awareness and feed the discussion, in a new context resulting from the Covid-19 pandemic experience, on the relevance of localising the SDGs and the recognition of their cultural dimension. The methodology of the Seven Keys workshop allowed to gather 36 people, coming from different areas of the cultural field, but also coming from social affairs, relation with citizens and with the parishes, economy and innovation, environment/green areas, urbanism, local development and international relations, from both civil society organisations and the various services and departments of the City Council. The first part of the workshop took place on 28 June 2021. It focused on linking SDGs with the city challenges and the local cultural resources and dynamics. The second part of the workshop took place on 5 July 2021. Participants identified numerous potential actions, through a "brainstorming" exercise, which were analysed, discussed and grouped until the group reached a consensus over 7 actions "The Seven Keys". Cristina Farinha, an independent researcher and expert specialised in culture and the creative economy, facilitated the workshop.





## PUERTO DE LA CRUZ:

The city of Puerto de la Cruz (Tenerife, Spain) was the host of a Seven Keys workshop on 8 and 22 April 2021. Located in the north of the island of Tenerife, Puerto de la Cruz is the smallest municipality in the Canary Islands (Spain), spanning just 8.9 square kilometres, with a population of 30,000, which coexists throughout the year with a floating population of visitors. The Seven Keys workshop was organised in tandem with other participatory processes on culture in 2020 and 2021, in order to help foster the revision and updating of local cultural policies. The workshop brought together around 30 people from the cultural and heritage sectors, as well as from social, economic and tourism, and environmental and urban planning fields, both from civil society as well as specialists and politicians from different areas of the Town Council. The process allowed participants to jointly define the challenges facing Puerto de la Cruz, to examine local cultural policies and actions in reference to the SDGs, and, above all, to define six major Key Actions in order to respond to these local challenges. Participants finally proceeded to define each of these six actions in a creative manner using precise and explicit words, sometimes with drawings, to express key ideas and messages. Antoine Guibert, expert of the UCLG Committee on Culture, facilitated the workshop.



## XI'AN:

In Xi'an (China), the Seven Keys Workshop took place successfully on 9 December 2021 on behalf of Xi'an Municipal People's Government, Xi'an Foreign Affairs Office and the Committee on Culture of UCLG. Organisers of the workshop invited 24 participants with diverse backgrounds, including specialists recommended by municipal government agencies, practitioners, entrepreneurs, young people, and international residents from culture, heritage protection, business, environmental protection, urban planning, and tourism fields. The workshop consisted of three parts. The first part focused on local challenges and SDGs. The participants were invited to list main challenges of Xi'an's development based on their understanding and experience. The participants pointed out 22 main challenges, covering culture, technology, environment, economy, education, urban structure, internationalisation, etc. The second part was about 'Cultural Mapping' and 'Spotting the Gaps'. The participants were randomly divided into five groups to discuss local cultural elements and match them with the SDGs. Furthermore, facilitators introduced examples of good practices from other cities in the UCLG OBS Database to explore potential opportunities to link cultural elements with SDGs more effectively. The third part consisted of the key discussion on the Seven Keys and its final formation. Through categorisation and classification, all participants eventually reached a consensus on the final seven keys which meet all requirements. The workshop was facilitated by Mr. Shi Qi, Director of Xi'an Center for International Friendship Cities, Mrs. Wang Chenjia, Dean of Cross-cultural Studies Institute, Northwest University, and Mr. Wang Youqun, Dean of School of International Education, Xi'an University of Architecture and Technology.

## MEDELLÍN, SEGOU, EUSEBIO LEAL AND VANDANA SHIVA, WINNERS OF THE 4TH EDITION

The International Award UCLG - Mexico City - Culture 21 is organised by the City of Mexico and United Cities and Local Governments to recognise cities and local or regional governments' cultural policies and practices for sustainable development.

Every two years, an International Jury composed of prestigious international experts acknowledges key contributions to culture and sustainable cities and territories worldwide through two categories, namely: "Local or Regional Governments" and "Individuals".

After three successful first editions in 2013-2014, 2015-2016 and 2017-2018, which gathered some 240 candidacies and awarded the cities of Belo Horizonte (Brazil), Lyon (France), Seongbuk (Republic of Korea), Timbuktu (Mali), Vaudreuil-Dorion (Quebec, Canada), as well as Manuel Castells, Basma El-Husseiny, Jon Hawkes, Patrice Meyer-Bisch, Silvia Rivera Cusicanqui and Farida Shaheed, a 4th edition was organised in 2019-2020.



This new edition of the Award received 81 proposals from cities and local governments from all regions of the world. The cities of Medellín (Colombia), and Segou (Mali), were designated as winners by the Jury, who also recognised Eusebio Leal and Vandana Shiva for their tremendous work on culture and sustainability.

With this 4th edition, the Award reaffirmed the critical place of culture in development at all levels. It demonstrated that the localisation of the Sustainable Development Goals cannot be achieved without the cultural dimension of development, and it made visible how cities and territories daily contribute to the wellbeing of communities.

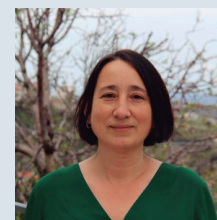

## THE NETWORK OF ARTS AND CULTURAL PRACTICES OF MEDELLÍN

The Network of Arts and Cultural Practices was created 24 years ago, involving different artistic and cultural groups and organizations. The aim of the programme is to guarantee cultural rights for children, adolescents and youth. This community-oriented initiative supports more than 7,800 children and youth in the 16 communes and 5 townships of **Medellín** every year, providing them with opportunities for expression, exchange, learning, experimentation and enjoyment with a wide range of artistic, aesthetic, and cultural forms, including dance, performing arts, fine and visual arts, music and audio-visual. With this project, public access to culture in Medellín has increased by improving cultural infrastructure throughout neighbourhoods, setting up cultural training opportunities, and promoting specific programmes and offers for disadvantaged groups, in close collaboration with other municipal plans and programmes. Over the years, the Network of Arts and Cultural Practices has contributed to promoting and reinforcing Medellín as a cultural city committed to inclusive and participatory cultural policies aimed at enshrining cultural citizenship, sustainable development, and an improved quality of life and well-being for all inhabitants.

## A LIFE DEDICATED TO THE PRESERVATION OF THE HISTORICAL AND CULTURAL HERITAGE OF CUBA

Dr. **Eusebio Leal** has devoted his entire life to the preservation of the historical and cultural heritage of Cuba and of humanity. Dr Leal's distinguished sensibility, as well as his early incursion into public administration, allowed him to understand the scope and value of the cultural heritage of cities, particularly Havana, both for its citizens and for the rest of the world. He is Honorary President of the Cuban Committee of the International Council of Museums (ICOM) and Honorary President of the Cuban Committee of ICOMOS and of the Civil Society Heritage, Community and Environment; Professor Emeritus of the University of Havana and Doctor Honoris Causa in various prestigious universities worldwide. He chairs the Network of Offices of the Historian and Conservator of the Heritage Cities of Cuba. Throughout his professional career he has promoted the embodiment of the public space as a cultural space, preserving heritage as a common good through the restoration and conservation of the different works and projects he has been in charge of, with special emphasis on the Historical Centre of the city of Havana. Havana is today a complete and absolute symbol of this effort. For Dr Eusebio Leal, the city is highly representative of all the cultural, intellectual, political, historical and social values of the Cuban people, and it is also a great memory of the architectural development that succeeded in making Havana one of the most important post-colonial cities in Latin America.

## VANDANA SHIVA

THE PIONEERING FIGURE OF ECOFEMINISM,  
KNOWLEDGE AND CULTURE

Dr. **Vandana Shiva** is one of the pioneering figures of ecofeminism most recognised worldwide. Born in Dehradun, India, Ms Shiva is doctor of Physical Sciences, philosopher of science, ecologist, feminist and pacifist. She directs the Research Foundation for Science, Technology and Natural Resource Policy (RFSTN) in India, which she founded in 1982. She is also the founder of Navdanya, a movement focused on women and dedicated to the promotion of biological and cultural diversity. In her defence of the food cultures treasured by indigenous peoples and their cultural and natural heritage, Vandana Shiva has explicitly linked issues such as food security and climate emergency to neoliberalism, cultural relativism, and the colonization and spoliation of traditional agricultural knowledge. In this sense, she has provided keys to place culture at the core of the global debate on humanity's challenges. She has especially helped put women and girls, and biodiversity at the forefront of the fight to implement human rights policies, the Sustainable Development Goals, and other global agendas. Her approach to ecofeminism emphasizes scientific knowledge and dissemination as tools to preserve biodiversity and the autonomy of food cultures, and to guarantee people's cultural rights, including the most at-risk groups, without leaving anyone or any place behind.

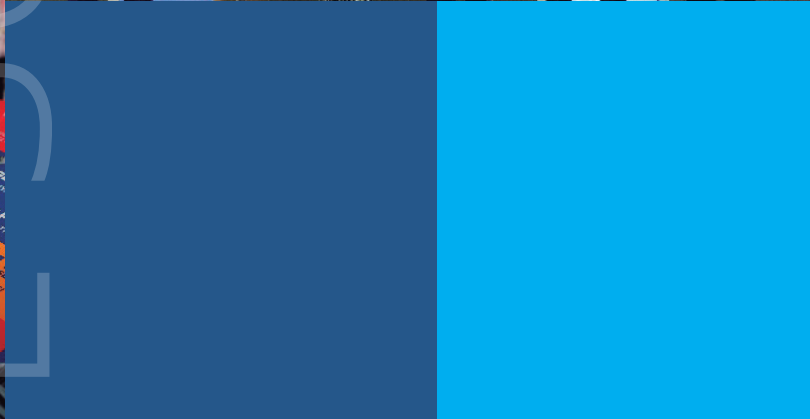

# THE SUMMIT



## Izmir 2021

### Culture: Shaping the Future



From the 9th to the 11th of September of 2021, the city of Izmir held the **4th UCLG Culture Summit** at the Kültürpark, one of the main landmarks of the city.

Since the first edition back to 2015, the UCLG Culture Summit is the main meeting point at global level of cities, local governments and other stakeholders that are committed to the effective implementation of policies and programmes on culture and sustainability. This Culture Summit in Izmir was built on the results of the previous three editions, held in the City of Bilbao (Basque Country, Spain, March 2015), the Jeju Special Self-Governing Province (Jeju-do, Republic of Korea, May 2017), and the Autonomous City of Buenos Aires (Argentina, April 2019).

However, for the first time, the Summit was also inevitably and significantly influenced by the global pandemic of Covid-19, especially in terms of sanitary measures and traveling restrictions. Therefore, the format of the Summit was reinvented into becoming a hybrid event, enabling physical participation for those who could travel to Izmir, and receiving virtually the people that could not be there physically but still wanted to take part in this unique experience. In other words, the pandemic filled the situation with uncertainty but after all, and as a result a combination of technological tools to virtually connect from any corner of the world and the eagerness to gather and exchange knowledge, practices and experiences, culture prevailed.

The Summit considered the impact of the sanitary crisis, which had made evident the profound need for culture that cities and communities have: people turned to culture to reinforce their sense of belonging in communities and cities, inventing new forms of participation,

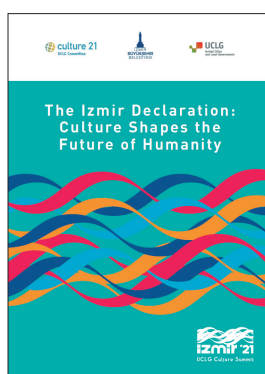
recognising what brings us together and creating meaning and solidarity. The pandemic had actually also shown that cultural actors need better working conditions, which were already precarious and difficult in the old normality. The Summit made obvious the fact that life after pandemic would have to place culture at the centre of development. The time had come to think beyond the circumstances of that time, and to be brave enough to imagine different, better and more sustainable ways to live together.

The place was Izmir, a Mediterranean metropolis that is a wonderful crossroad of peoples, knowledges and dreams. The Summit showed that cities are leading the way in recognising the absolute necessity of cultural factors as a key dimension of sustainable development. This is why the 4th UCLG Culture Summit was called **“Culture: Shaping the Future”**.

The Summit had two main goals. The first was to reinforce the messages about the role that culture plays in sustainable development at the local level, with concrete examples of policies, programmes and projects from all corners of the world. In all cities, worldwide, there are extraordinary initiatives that manage to expand freedoms and improve the lives of people through cultural processes, whether in the field of heritage, creativity or diversity. Also, the Covid-19 pandemic had made more evident the importance that those initiatives play in sustainable development, and reinforced the claims of our toolkit Culture 21 Actions (approved in 2015) to fully integrate cultural factors into local sustainable development.

On the other hand, the Summit aimed to give visibility to international debates on culture, cities and sustainable development, which were by that time shaped by the UN 2030 Agenda and the SDGs (we were already in the Decade of Action), the New Urban Agenda (which celebrated its 5th anniversary in 2021) and the UCLG acquis on the place of culture in local development (with the [Bogotá Action Plan](#) and the [Durban Political Declaration](#)), reinforced in 2020 by the [Presidential Decalogue for the Covid-19](#) aftermath and the announcement of a new [UCLG “Pact for the Future of Humanity”](#): for People, for the Planet, for the Government”, to be shaped during 2021 and 2022, and to be powered by solidarity, equality, culture, and accountable institutions that leave no one and no place behind.

The Summit was the place to share and discuss. We brought all stakeholders in the room, not only those that have already worked together, but also new voices and champions to ensure a future for the younger generations. A world that leaves no one and no place behind is impossible without culture. As a forum for knowledge-sharing, peer-learning and networking among

cities and local governments, the Summit made it clear. Over three days, it received almost 400 physical participants from all world regions, and over 600 attendees online. With a combination of Plenary and Parallel sessions, as well as Workshops and Hub Talks, the Summit favoured the proximity with the attendees so as to encourage their participation, networking spaces, and finally, cultural routes for the physical participants to discover the extraordinary cultural heritage of Izmir.

The 4th UCLG Culture Summit successfully came to an end with the release of the **Izmir Declaration: "Culture shapes the Future of Humanity"**, which was not only the main outcome of the very important debates and strong messages that had been shared and sent all along the three days of meetings, but also a substantial contribution to the UCLG Pact for the Future of Humanity: for People, for the Planet, for the Government, which was to be adopted in the second half of 2022, and would be underpinned by the values of culture, care and solidarity.

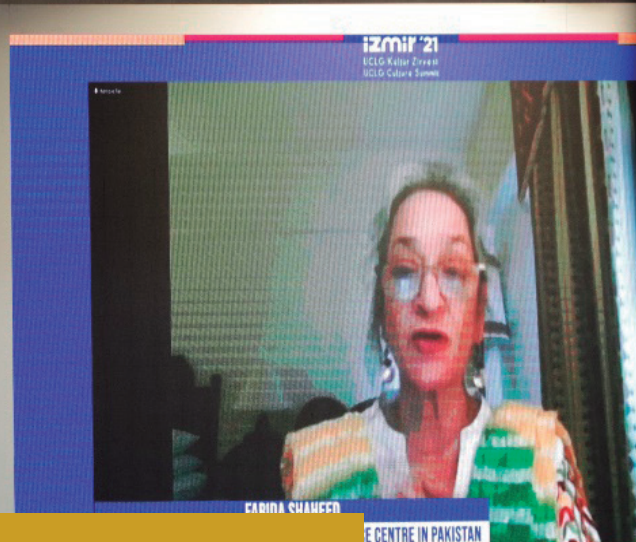

# CULTURE IN THE SDGS: THE #CULTURE2030GOAL CAMPAIGN

In 2020 and 2021, the #Culture2030goal campaign continued its efforts in order to include a Culture Goal in the 2030 Agenda of the United Nations. The campaign is formed by the following global cultural networks united to advocate for the role of culture in sustainable development: Arterial Network, CAE – Culture Action Europe, ICOMOS – International Council on Monuments and Sites, IFCCD – International Federation of Coalitions for Cultural Diversity, IFLA – International Federation of Library Associations and Institutions, IMC – International Music Council and UCLG (United Cities and Local Governments) Culture Committee – Agenda 21 for Culture.



## #Culture2030goal Statement on “Culture and the COVID-19 pandemic.”

In April 2020, the [#Culture2030goal](#) campaign published the Statement “[Ensuring culture fulfils its potential in responding to the COVID-19 pandemic](#)”. The Statement emphasises the need to place culture at the heart of the response to the Covid-19 crisis today and at the centre of all endeavours, at all scales, to rebuild our societies. In July 2020, the statement was [endorsed by the President of the United Nations General Assembly](#).

## Advocacy activities

In July 2020, the #Culture2030goal campaign organises the side-event “[Culture – An Accelerator Under-Used? Realising the Potential of Culture for Short-term and Long-term Sustainable Development](#)” in the context of the United Nations High Level Political Forum 2020 (HLPF2020). In April 2021, the online event “[Upgrading Culture in Sustainable Development: The Time is Now](#)” was organised with UN Habitat and Metropolis, and in partnership with the #Culture2030goal campaign, Rome City Council and Palaexpo, in the context of the “[Cities Are Listening](#)” series. In July 2021, the #Culture2030goal campaign participated at the side-event “[Partnering through Culture, Heritage and Art for Resilient and Inclusive Recovery](#)” at the HLPF 2021.

### A renewed vision.

In May 2021, the campaign approved a renewed strategic framework within the context of the UN Decade of Action. The new [Vision and Strategy](#) document defines a new Vision: “The recognition of culture as the fourth pillar of sustainable development” and Mission: “To mainstream culture across the global development agenda”. Furthermore, the Goals of the campaign include a stronger place for culture throughout the implementation of the current global development agenda (the UN 2030 Agenda), the adoption of culture as a distinct goal in the post-2030 development agenda, and the adoption of a global agenda for culture.



### Report on Culture in the VLRs.

In December 2021, the #Culture2030goal campaign elaborated a new report on “[Culture in the Localization of the SDGs: An Analysis of the Voluntary Local Reviews \(VLRs\)](#)”. The main findings of the analysis show that there is great diversity of how local and regional governments (LRGs) address culture in their sustainable development policies and reporting. A good majority of VLRs have included the cultural dimension in their implementation of the 2030 Agenda, through substantive narratives. Cultural topics can be found at any level, as part of high-level policy frameworks and as practical examples of implementation, as separate sectoral headings, where LRGs have dedicated ‘cultural plans’, or supporting aspects of other policy headings, diffused throughout different Goals and Targets.

# THE OBS OF GOOD PRACTICES

## INTRODUCTION

Since its creation in 2004, the UCLG Committee on Culture has accumulated more than 15 years of practices and specific experiences. The Secretariat of the Committee has worked on capitalising these experiences through the creation of a database, among other things, which is now better known as the "OBS", a database of "good practices" on culture and local sustainable development. The projects presented on this platform are indexed according to different parameters and selected on the basis of a set of criteria.

### The indexation tool

The database relates to 3 different kinds of indexation parameters which also serve as searching tags:

- **SDGs:** all good practices are indexed according to the 17 Sustainable Development Goals (SDGs).
- **CULTURE 21 ACTIONS:** all good practices are indexed according to the 9 commitments (or "themes") of Culture 21 Actions.
- **KEYWORDS:** all good practices are indexed according to a list of 75 keywords, addressing all areas of culture, cultural policies and sustainable cities.

## THE CRITERIA OF SELECTION

The identification and selection of good practices builds on an evaluation process based on the following six criteria: innovation, participation, sustainability, efficiency, transversality and reproducibility.



## THE GOOD PRACTICES

Throughout 2020 and 2021, a total of 78 new good practices were integrated to the recently created OBS database, built on a good practices collection which originally included 209 case studies, bringing the total number of practices to 287 at the end of 2021.

# Finding Synergies with new Partnerships

In 2020-2021, the UCLG Committee on Culture has developed new partnerships, while simultaneously strengthening the existing ones, both to build and find new synergies with other international actors and organisations.

These partnerships include, among others, those with:



## ICOMOS

UCLG and the International Council of Monuments and Sites (ICOMOS) have been collaborating historically on several initiatives. This partnership has been recently strengthened through the signature of a Memorandum of Understanding (MoU) on the 9th September 2021, within the [4th UCLG Culture Summit](#) in Izmir. The MOU aims to establish a general framework of cooperation to place culture and heritage at the heart of the global conversation on sustainable development.

The most remarkable partnership among the UCLG Committee on Culture and ICOMOS is the one formed under the #Culture2030Goal campaign, aiming to jointly advocate for the role of culture as the fourth pillar of sustainable development, and to mainstream culture across the global development agenda.

## Global Youth Culture Residencies

The formerly named "Global Youth Culture Forum" (GYCF) takes a new form, and is renamed "Global Young Creatives Residencies" (GYCR) for its 2021 edition. This initiative, promoted by the Jeju Special Self-Government Province and the Jeju Foundation for Arts and Culture, and supported by the Committee on Culture of UCLG and the Jeju Free International City Development Center (JDC), links culture to the sustainable development of Jeju.

In 2021, the GYCR invited young artists to Jeju Island, as an international art exchange project, to engage in creative activities and share inspiration. A system of online pre-lectures and isolated residency programs were initiated due to the COVID-19 pandemic. The results from the 5-day residency program were presented through an online platform.

### The Climate Heritage Network - CHN

On 24-25 October 2019 the UCLG Committee on Culture supported the launch of the [Climate Heritage Network](#), and since then, they have closely collaborated with the CHN on numerous occasions.

Towards the 2021 United Nations Climate Conference (COP26), the Climate Heritage Network released the **Manifesto Culture At COP26** '[Accelerating Climate Action through the power of Arts, Culture and Heritage. A Manifesto on Keeping 1.5° Alive](#)', which was supported by the UCLG Committee on Culture in its elaboration and dissemination processes. Also, in the frame of Culture at COP26, and in close cooperation with the CHN, the UCLG Committee on Culture also participated in 2021 in several activities to advocate for the voice of cultural actors to be heard, and for their role as key players in Climate Action to be recognised at all levels. Culture at COP26 hosted a series of events that aimed to accelerate climate action through arts, culture and heritage.

The Committee on Culture of UCLG also worked on a report entitled 'The Role of Culture in Climate Resilient Development', in close collaboration with the Climate Heritage Network Working Group 5. This research work has been led by Andrew Potts, coordinator of the Climate Heritage Network, and documents the initiatives of cities and local or regional governments from all continents on cultural policies, sustainable cities and climate resilient development. The report was presented as a draft on 9 September 2021 at the UCLG Culture Summit held in Izmir and Online, at the workshop session "Culture and the Climate Emergency. Local Experiences towards COP26". The final version was published in November 2021.

Projects will seek sustainable outputs and will foster multi-stakeholder national and transnational cooperation, inclusive societies, cultural diversity and equal dignity for all.

This is an initiative co-funded by the European Union. It includes two calls for proposals to support around 50 projects in 15 African countries.

The main findings of the analysis show that there is great diversity of how local and regional governments (LRGs) address culture in their sustainable development policies and reporting.

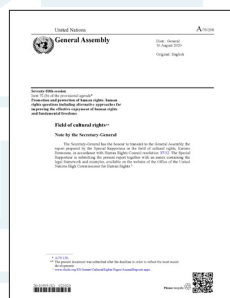

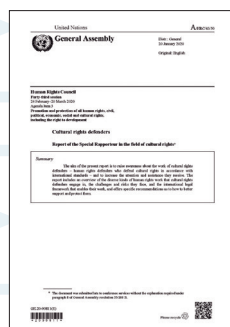
### **Our Common Agenda. Report of the Secretary-General. United Nations, NY, 2021.**

This report is the Secretary-General's vision for the future of global cooperation. It calls for inclusive, networked, and effective multilateralism to better respond and deliver for the people and planet and to get the world back on track by turbocharging action on the Sustainable Development Goals. It outlines possible solutions to address the gaps and risks that have emerged since 2015, calling for a Summit of the Future that will be held in 2024.



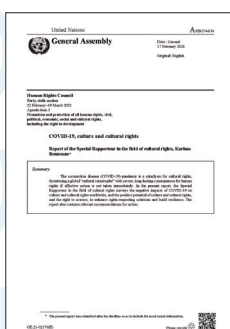
### **Benounne, K. (2020) Report on climate change, culture and cultural rights (A/75/298).**

The Special Rapporteur in the field of cultural rights, Karima Benounne, addresses the cultural and cultural rights dimensions of the current climate emergency, which have too often been overlooked. She considers the negative impacts of climate change on human cultures and on the enjoyment of cultural rights, and the positive potential of cultures and the exercise of cultural rights to serve as critical tools in responding to the climate emergency.



### **Benounne, K. (2020). Cultural Rights Defenders. (A/HRC/43/50).**

This report is intended to raise awareness about the work of cultural rights defenders, with a view to enhancing the attention and assistance they receive. The Special Rapporteur stresses that defending cultural rights not only contributes to the protection and promotion of all interdependent and interrelated human rights, but also to the realization of the sustainable development agenda and to effective response to the climate emergency.



### **Benounne, K. (2021). Report on the impact of the COVID-19 pandemic on cultures and cultural rights. (A/HRC/46/34).**

This report focuses on the impact of the coronavirus (COVID-19) pandemic on cultures and cultural rights and the potential global cultural catastrophe it represents, with severe, long-lasting consequences for cultural rights and other human rights. It is informed by a questionnaire which was disseminated widely to States, regional and local governments, international and regional organisations, National Human Rights Institutions, equality bodies, and civil society organisations, UN agencies, funds and programmes and other interested stakeholders in May 2020.



### **A Cultural Deal for Europe. Make culture central in the EU's green and sustainable future. Annual policy conversation.**

The third edition of the Annual Policy Conversation "A Cultural Deal for Europe" brought the European cultural ecosystem in a dialogue with EU policy-makers, advocating for culture to be central in the EU's green and sustainable future.






# In memoriam

**Eusebio Leal**, winner of our Award in 2020, left this world days after having been recognised by the Jury. Architect Leal devoted his entire life to the preservation of the historical and cultural heritage of Havana and Cuba.

**Carl-Johan Kleberg** passed away in 2020 after a long career in Sweden and international, with UNESCO's World Commission for Culture and Development (Our Creative Diversity, 1996) and the Council of Europe. He was very active in the cultural policy debate and was the first person to imagine an "Agenda 21 for culture", as a global commitment for culture and development.

Our dear colleague and friend **Kim Dunphy** passed away in 2020. She was a core member of the Cultural Development Network of Australia and her work greatly contributed to the understanding of culture and the way it impacts our lives.

We were also surprised by the unexpected and unfair passing of **Javier Brun**. A friend, a man of consensus and an engine of cultural cooperation in Aragon, Spain, Europe and the Americas, especially with Interarts Foundation, Javier Brun had greatly contributed to the foundation of the UCLG Culture Committee.

**Roger Tropeano** passed away after having devoted his life to the progress of local cultural policies, in France and in Europe. He was the founder and the president of "Les Rencontres", one of the first cultural networks, and he was involved in the initial steps of Agenda 21 for culture.

**Enrique Rodríguez Martín** devoted his professional career to the cooperation among cities from his hometown, Gijón, as municipal director for Europe and international affairs. He strongly advocated for the importance of culture in urban policies.
